The Mkalama District Council now invites sealed Tenders from eligible *National* Contractors registered with the Ministry of Water and Irrigation and CRB as Drilling Contractor Class VI and above for carrying out **Conducting Geophysical Survey, Drilling of Exploratory and Productive wells (Drilling, Development and Installing Afridev Hand Pumps)** for Lukomo, Ishinsi, Ishenga, Nkungi, Malaja, Nkalakala, Mgolombyo, Kinyambuli, Gambasimboi, Mnung'una, Ikungu, Mdilika, Mkiko, Singa, Tumuli- Makambi ya Fisi and Igonia Villages.
