1. The Government of the United Republic of Tanzania has set aside funds (WSDP) for the operation of the Mkalama District Council during the financial year 2017/2018. It is intended that part of the proceeds of the fund will be used to cover eligible payment under the contract for the **Construction of Piped Water Supply Schemes for Kinyangiri and Nduguti Villages and Rehabilitation of Ipuli Village Water Supply Sub-Projects.**
2. The Mkalama District Council now invites sealed Tenders from eligible *National* Contractors registered with the CRB as Civil Contractor as indicated in the table below for carrying out the above mentioned tender for the duration of 240 Calendar days.

Tenders will be opened promptly thereafter in public and in the presence of Tenderers' representatives who choose to attend in the opening ceremony at the **District Council Hall in Nduguti**.
